Reconciliation Grant Application Information

**General Information:** The purpose of the Reconciliation Grant Program is to support congregations within the CCNC/N Region in their endeavors to address local issues of poverty, justice, peacemaking, and multi-cultural awareness. Endeavors addressing root causes of racism are especially welcome. The term "reconciliation" in the context of this grant program intentionally holds a broad meaning so grant applicants may be creative in their project proposals. Applications may be submitted at **any time**. The review process will take place in **February** and **July**. *Emergency grants may be considered. Contact the Regional Office for information on processing an emergency grant.*

The maximum grant award for project proposals is generally \$2,000. Funding for reconciliation grants comes from the Reconciliation Offering received by congregations in the CCNC-N.

**Funding Eligibility Criteria:** All Christian Churches (DOC) within the CCNC/N Region are eligible to apply for reconciliation funding. **The project may be in conjunction with other churches or organizations, but the application must be initiated by the congregation or regional committee, or must have a very clear connection to the Christian Church of Northern California-Nevada. Funding will be disbursed as determined by the region's Reconciliation Committee.**

**Project Criteria:** Priority will be given to projects that meet **most** of the following criteria:

1. Projects aimed at empowerment of marginalized communities or the cultivation of relationships between different communities.
2. The marginalized people involved in the project are included in the decision making and planning of the project.
3. The project is likely to continue beyond the time span of the reconciliation grant. That is, the grant functions as seed money.
4. The congregation is a first-time applicant, or the program has not received prior Reconciliation funding.
5. The project receives a positive recommendation from the Regional Minister(s).

**Funding Limitations:** Funding will **NOT** be considered for the following:

1. Projects that deliver goods or services that are already provided in the community (duplication of services).
2. Capital expenditures such as buildings, fixtures, building renovations or high-cost equipment.

**Examples of Funded Projects:** In 2007, the following programs were supported:

- First Christian Church of San Jose has brought in the regionally renowned director of an interracial gospel choir to do a series of practices with members of their church and surrounding Disciples and ecumenical congregations and a series of performances. FCC San Jose will also use this time to reflect on issues relating to diversity in their own congregation.
- First Christian Church of Concord is incorporating documentary film making into their annual Mexico mission trip, so that the story of the people in Tijuana and the effects of globalization can be told at the same time that the youth's important work on building housing continues.
- Interfaith Ministries of Marin County is blessed by a Disciples pastor who serves as a chaplain to the street community there. Part of Pastor Paul Gaffney's gift to the region has been a willingness to preach, teach and reflect with congregations seeking to live out their call to unsheltered people.

**Deadlines:** These are still in formation, but tentatively the dates are January 30 and June 30.
